## 1. Junior Biodiversity Project Fellow :(Number of Post -5) (At Nagpur)

**Eligibility**: A candidate must have Post Graduate (Master's) Degree in Botany, Zoology, Biodiversity, Life Science, Microbiology, Ecology, Crop science, Biosystematics, Agriculture, Forestry, Wildlife Science or Environmental Science with at least 55% mark (50% in case of SC/ST candidates) with consistently good academic records and must have proficiency in Marathi & English (read, write and speak) along with UGC NET / GATE qualification
