**I. Eligibility Criteria for Application**

1. Only Indian Nationals are eligible to apply.
2. The candidate should have passed their Diploma in above mentioned branches recognized by AICTE or GOI **on or after 01/10/2021**.
3. **Age limit:** Maximum age should not be more than **25 years as on 01/10/2024**. Upper age relaxation of **5 years** for **SC/ST** and **3 years** for **OBC** & **10 years** for **PWD candidate**.

**II. General Instructions:**

1. Candidates who fulfill all the above criteria are eligible to apply.

2. The duration of Apprenticeship training is one year.
3. Stipend shall be paid as per Apprentices Act, 1961 (as Amended).
4. Candidates can apply for the above vacancies through Portal [nats.education.gov.in](https://nats.education.gov.in) **on or before 04/11/2024.**
5. The candidates should not have completed or undergoing apprenticeship training in other organization Candidates who have already completed their apprenticeship or terminated their apprenticeship mid-way or pursuing their apprenticeship with other organizations are not eligible.
6. Reservation for SC/ST/PWD/ OBC/EWS etc. candidates will be as per the Government guideline.
7. During the period of apprenticeship, candidates will be governed by the 'Apprentices Act, 1961 as well as the policies/rules of the organization.
8. Canteen facilities will be available on chargeable basis.
9. Interested candidates are required to register on BOAT portal [nats.education.gov.in](https://nats.education.gov.in) the application received after last date **(i. e, 04/11/2024)** will not be considered.
10. The shortlisted candidates will be informed for Written test through their registered E-mail ID.
11. The number of vacancies to be engaged is indicative and may be changed by Management without any further notification and without assigning any reason thereof.
