18 (eighteen) months

V. DAILY WORKING HOURS:

8 hrs shift - One day off per week.

VI. STIPEND :

Stipend per month **Rs.10000/-plus**

VII. ACCOMMODATION:

Shared accommodation subject to availability.

VIII. MEDICAL FACILITY:

For self at CFP Dispensary and OHS only during training.

IX. LEAVE:

During the period of their training, they shall be entitled to 7 Days of casual leave and closed holidays(or Compensatory off) for National Holidays.

x. PROCEDURE:

- (a) Candidates have to appear for walk-in interview as per the schedule mentioned below with filled-in & signed application in prescribed format (Annexure-A) and Letter of undertaking (Annexure-B) with documents/testimonials as per instruction &/or eligibility. **However, screened candidates, chosen on first-cum-first-serve basis, will be interviewed.** If the number of Candidates increased then interview will be continued on other day subject to their appearance in scheduled time.
- (b) Selection for 'Proficiency Training' will be done by judging their performance through Interview. In case of tie in final cut off score, candidate(s) with higher percentage of marks in aggregate of qualifying qualification (B.Sc. / Diploma in Nursing) shall be selected.

- (c) All certificates/ documents in support of eligibility will be verified with the original during interview & joining and if any candidate fails to produce the same, he/she will not be allowed to appear for interview/join and their candidature will be cancelled. Therefore, candidates are advised to ensure their eligibility and validity of the certificates/documents on date of interview before applying and appearing for the interview.
- (d) If the selected candidates are not in possession of the “Certificate of Registration” at the time of joining, they will have to deposit the same within three months from the date of their admittance as proficiency trainee nurses. Till such time, the admittance of the proficiency trainee nurses will be Provisional.
- (e) ‘Proficiency Training’ will start shortly after the selection of the candidates is completed and Offer of Admittance as “Proficiency Trainee Nurse” are issued.
- (f) The trainee shall follow the norms of safety, Discipline, Conduct and Professional Ethics and also carry out the lawful orders of the Medical Administration issued from time to time. The trainee shall obey all such orders and direction as received from the superiors.
- (g) On completion of training in CFP for 18 months, a ‘Certificate of Proficiency’ will be issued by CFP-OHS center to the successful candidates based on their satisfactory performance. The certificate will not be issued in cases of provisional engagement as mentioned at (XI)(d) above or in case of failure to complete entire duration of the training.

XI. HOW TO APPLY:

Eligible & interested candidates are required to appear for walk-in interview as per the schedule.

XII. GENERAL CONDITIONS:

- (a) Candidate must be an Indian national possessing requisite qualification from an Institute recognized by State Govt. / Central Govt.
- (b) The minimum age of engagement as “Proficiency Trainee Nurse” is 18 years.
- (c) All certificates in respect of eligibility criteria viz. requisite educational & professional qualification, experience, caste/category, proof of date of birth etc. are to be valid on the date of walk-in interview. OBC-NCL (Non-Creamy Layer) certificate and Income & Asset certificate for EWS category should be valid for the Financial Year 2024-25 (i.e. issued on or after 1st April, 2024)
- (d) Candidates will have to attend the interview at schedule date & time at their own cost.
- (e) The engagement is purely for the purpose of “Proficiency Training’ and will not entitle the trainee to stake a claim for appointment in Chandrapur Ferro Alloy Plant in any manner whatsoever.
- (f) During the training period of 18 months, the trainees will be paid monthly stipend of Rs.10,000/- and applicable Knowledge Enhancement Allowance linked to monthly attendance from the date of their admittance as detailed in point VII.
- (g) CFP reserves the sole authority/ prerogative in the matter of admittance of “Proficiency Training” of nurses as per its rules and decision of CFP in this regard shall be firm & binding.
- (h) CFP reserves the right to reject **OR** cancel the candidature **OR** the entire process including interview or admit less than the no. of Proficiency Trainees indicated above, without assigning any reason thereof and no enquiry or correspondence will be entertained in this regard.
- (i) Bringing influence at any stage of the selection process will disqualify the candidature.
- (j) Candidature of an applicant is liable to be rejected/terminated at any stage of the selection process or after selection or admittance if,
 - any information provided by the candidate is found to be false
 - OR
 - found not in conformity with requisite eligibility criteria mentioned in the advertisement
 - OR
 - Impersonation during selection process including interview.
